#### Protecting the Right to Vote (Substack.com, Joyce Vance from Civil Discourse)

On August 18, I wrote to you about <u>Trump's "Truth"</u>—his social media post—about voting. It was a screed that pulled in all of the debunked threads he's used over time to support his completely unsubstantiated claim about massive fraud in American elections. In his post, he complained about mail-in ballots, voting machines, and cheating Democrats. He moved on to open borders and men playing women's sports, neither of which has anything to do with elections, but he was on a roll at that point.

Midway through, he came out with something new and truly alarming. He wrote that "the States are merely an 'agent' for the Federal Government in counting and tabulating the votes. They must do what the Federal Government, as represented by the President of the United States, tells them, FOR THE GOOD OF OUR COUNTRY."

The states are not agents of the federal government when it comes to holding elections. The Elections Clause of the Constitution, Article I, Section 4, Clause 1, gives them control over the times, places, and manner of holding elections, subject only to *congressional*, not presidential, action. But Trump, who has been on a power grab ever since he took the oath of office, wants to claim this real estate for himself, too. And there is news today confirming that he is firmly on that path.

#### New state guidance aims to clarify COVID-19 vaccine access after weeks of confusion (Cardinal News)

A COVID-19 outbreak hit Jan Keister's workplace at a law office. Three days ago, she tried to get vaccinated to protect herself and her immunocompromised partner but wasn't able to get the shot at a pharmacy or from her doctor's office.

Her regular pharmacy in Roanoke said she needed a prescription, even though she's over 65 and qualified under new federal COVID-19 regulations. Staff at her doctor's office said they didn't yet have doses for the 2025-26 season. She stopped at an urgent care clinic, where they told her she could get one, but the visit would cost her \$80 and she would have to wait at least an hour to see a doctor.

Over the last few days, the requirements for accessing the vaccine have shifted rapidly. On Wednesday, the <u>Virginia Department of Health issued new guidance</u> aimed at resolving the confusion — at least for a while.

#### SNAP cuts loom, and Nonprofits fear They can't fill the Gap Left Behind (Cardinal News)

More than two months after Congress passed the One Big Beautiful Bill, state and local leaders still have more questions than answers regarding how federal cuts will affect the Virginians who rely on SNAP to get food on the table.

One thing those leaders know for sure is that food is expensive, and the federal government is splitting the check with states for the first time in SNAP's history. The legislation is expected to shift up to \$352 million of costs from the federal government onto the state of Virginia by October 2027, according to an <u>analysis</u> conducted by Voices for Virginia's Children.

The One Big Beautiful Bill, signed into law on July 4, will reduce federal spending for SNAP by \$186 billion over the next 10 years, according to <u>estimates from the Congressional Budget Office</u>. The cuts will affect the more than 40 million Americans who receive SNAP benefits in different ways, <u>as they arise from eight</u> different sections of the megabill.

In Virginia, about \$1.76 billion in federal SNAP benefits were distributed to 874,000 people — that's about 10% of the state's population — in fiscal year 2024, according to the <u>Office of the Governor</u>. More than half of those Virginians are expected to lose all or some of their benefits under new federal rules.

VA Senate Privileges & Elections Chair Aaron Rouse Is Right: Youngkin's New Executive Order Is "voter suppression and intimidation disguised as election integrity" (Blue Virginia)

Senator Aaron Rouse Condemns Youngkin's New Election Order as "Voter Suppression Disguised as Integrity"

VIRGINIA BEACH, VA — Senator Aaron Rouse, Chair of the Senate Privileges and Elections committee, today issued the following statement in response to Governor Glenn Youngkin's new executive order on election security, issued just one week before early voting begins in Virginia:

"This is voter suppression and intimidation disguised as election integrity, just a week before early voting begins in Virginia. Voter fraud is virtually nonexistent, and our elections have been among the most secure in history. This is Youngkin's same repeated playbook. He pulled this exact move last year, took it all the way to the Supreme Court, and was allowed to reinstate his voter purge program. With President Trump now back in office, there is nothing stopping him from going even further. This is about undermining confidence in our elections and ultimately, our democracy."

Today, Governor Youngkin signed Executive Order 53, directing the Virginia Department of Elections to coordinate with federal agencies to "ensure that data is securely shared" and requiring the removal of allegedly ineligible voters from the rolls in accordance with state and federal law. The order also expands the use of the Department of Homeland Security's SAVE database, which is designed to identify non-citizens, and mandates election preparedness exercises before early voting begins.
